Infinity and AFC

- with regards to the acquisition of Lekela. Lekela develops mid- or late-stage green energy facilities into long-term operational and utility scale sites. Founded in 2015 and majority owned by sustainable infrastructure investor Actis, it operates more than 1 GW of wind facilities, with five wholly functioning sites in South Africa, as well as both operational facilities and forthcoming projects in Egypt and Senegal*

Tauber Solar

- in the negotiation of the concession for the construction, maintenance and operation of a 66-MW solar power plant and in the financing of this plant, in Ivory Coast*

Total Yunlin Holding

- in relation to the acquisition of 23 percent interest and refinancing of Yunlin Holding, the owner of the 640-MW Yunlin offshore wind farm off the coast of Taiwan. Located around 10 kilometers offshore, in water depths ranging from 7 to 35 meters, the wind farm, scheduled for completion in 2022, will comprise 80 wind turbines, each with an output of 8 MW. Once operational, the project will generate 2.4 TWh of renewable electricity per year, enough to meet the electricity needs of more than 600,000 homes.*
